THE CHALLENGE

Operating mining and metallurgical sites requires multiple suppliers. With safety a top priority and a corporate objective of 'zero harm' extending to contract suppliers and service providers, this sector leader set some of the highest standards in their industry. However, communicating and standardizing across their supplier base was proving a challenge and an administrative nightmare.

These high standards, coupled with a shortage of automated information management systems, resulted in considerable non-value-added administrative tasks and manual work to deliver on supplier health and safety performance expectations. The quest for supplier 'zero harm' consumed a tremendous amount of time in all departments, including procurement, health and safety, production and maintenance. To make matters worse, both the quality and relevance of information were often lacking due to the amount of work and constant changes in supplier files. Although the company was aiming high in the matter of supplier safety records, the process and tools were not up to the task.

THE SOLUTION

Prequalification:

- Select suppliers based on company standards and site-specific requirements
- Enable comprehensive display and secure archiving of supplier information, including insurance coverage, safety manuals, financial health, and criteria specific to sustainable development
- Send alerts and follow-ups based on deadlines and document requirements

Employee record management:

- Document supplier employee training including regulated mandatory training

 regardless of source (classroom or E-Learning) with the support of a
 dedicated back office team
- Advise suppliers of training and training organizations recognized by the plant
- Verify supplier employee compliance with health and safety competency requirements online
- Send proactive alerts when training and/or qualifications expire

Safety and environmental task analysis:

- Ensure ongoing management of specific risks for any work performed by suppliers at the site by providing a training gap analysis for each individual based on the scope of work and high-hazard activities
- Generate a detailed work permit after analyzing training required, necessary protective equipment, permits and best practices
- Enhance employee site access control via links to the site gatehouse security system

Based on their 12-month moving average, suppliers conducting work here achieved accident-free performance, reducing Total Recordable Injury Frequency (TRIFR) to zero.
